# Why not rent out your parking space?

Thousands of city dwellers are increasing their income by renting out garages and parking spaces to commuters. The trend is popular in the UK's cities with their no parking zones. Website *Gumtree.com* now includes a section for parking spaces next to apartments to rent and cars to buy. *Gumtree* says that the number of people advertising a parking space for rent has jumped 149% in the last six months compared with the previous six months. Could your parking space earn money? Sophy Silver from *Gumtree.com* said: "This is something that was happening informally at first. People

were coming to our website and advertising parking spaces so we set up a website section and it has become really popular." Amy Sebba has been renting out her garage in London since 2002 when she returned to full-time education. She said: "I bought an apartment in 2002 and it came with a parking space and a garage. I only needed one so I put an ad on *Gumtree.com*. I got 10 responses. The guy who rented it then still rents it now. I'm studying for an MBA and now have a regular income so the extra money is really useful." Amy gets £75 a month, or £900 a year, for her garage but has not raised the rent since 2002. Charles Cridland, founder of *Yourparkingspace.co.uk*, a business set up to advertise parking spaces, thinks that Amy could get much more – even as much as £250 a month for her London parking space, which is an annual income of £3,000. Charles Cridland also said: "The prices you can get are what people will pay. Our service operates in a number of cities and £100 per month is typical. Spaces in London cost more but other places are catching up." Charles Cridland said that stricter parking restrictions have pushed up demand for parking spaces and that this is the same in all cities in the UK.

## Could you rent out your parking space?

If you don't need it, then yes. Your space does not need to be a garage, or even covered, but it does have to be yours to rent out, i.e. owned by you rather than a landlord or other third party. The desirability of the parking space depends on the distance to a town centre, or transport links like major roads or train stations. It's not only driveways and garages that are rented out. Spaces far away from a property, such as underground parking, are also popular. Garages are the best spaces for cars or other storage and can cost £200 per week in London, says *Gumtree.com* – or £10,000 a year.

Once you have found someone to rent your parking space it is a good idea to write a simple contract that says how long the person is going to rent the space, between what hours, and for how much. It should be signed by both parties. And remember that the income you get is taxable.

Some websites allow you to advertise your parking space for free – like *Yourparkingspace.co.uk* and *Gumtree.com*. The other websites let you pay a percentage of the parking rent as advertising payment. However, no matter which method you use to advertise your parking space, you should not need to pay. Advertising a space using another method just needs details of its location, including its proximity to other transport and a picture if possible.

## How to get a new smile
